EQUITY SUMMARY

This week saw 1,715,197 shares traded on the First Tier Market, an increase of 5.10 per cent on last week's total of 1,631,990 shares crossing the floor. The value of the shares traded was down 4.28 per cent to \$13,473,075.18 from the previous week's value of \$14,075,863.15. Massy Holdings Limited (MASSY) was the volume leader this week with 35.34 per cent of the market activity or 606,211 shares traded, followed by NCB Financial Group Limited (NCBFG) with 20.80 per cent of the market activity or 356,806 shares traded. In third place was JMMB Group



Limited (JMMBGL) with 12.95 per cent or 222,189 shares traded. These shares accounted for 69.09 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 1.91 per cent or 22.21 points to close at 1,141.22. The All Trinidad and Tobago Index ended at 1,725.76, down by 2.02 per cent or 35.62 points. The Cross Listed Index slid by 1.50 per cent or 1.10 points to close at 72.18. The Small and Medium Enterprise Index ended at 78.90 unchanged from the previous week. This week there were 3 shares advancing and 16 shares declining, while 2 shares were at their 52-week high and 3 share were at their 52-week low.

The major advance this week was National Flour Mills Limited (NFM) up 12.00 per cent or \$0.24 to close at \$2.24, its 52 week high. In second place was Unilever Caribbean Limited (UCL) with an increase of 3.90 per cent or \$0.45 to close at \$12.00, Prestige Holdings Limited (PHL) followed with an increase of 0.70 per cent or \$0.09 to close at \$13.00.

Guardian Media Limited (GML) was the major decline this week down 10.00 per cent or \$0.20 to close at \$1.80, its 52 week low, The West Indian Tobacco Company Limited (WCO) followed with a decrease of 9.81 per cent or \$0.98 to close at \$9.01. In third place was Angostura Holdings Limited (AHL) down 6.00 per cent or \$1.20 to close at \$18.80.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 4,982 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$115,654.73. CALYP's unit price closed at \$24.00 up 4.35 per cent or \$1.00 from last week.

On the Small and Medium Enterprise Market, 1,470 Endeavour Holdings Limited (EHL) traded at a value of \$22,058.20 this week, while no CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$15.00 and CINE1 closed at \$6.45, both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


